

# REA Board Meeting Minutes March 17, 2015 - 6:00 p.m.

### 1. Welcome

Meeting called to order at 6:12 p.m.

## 2. Event Update: Life is Art - wrap up and feedback (Amy Bass & Elise Bratz)

Krista thanked Amy & Elise for a wonderful evening and presented a token of appreciation! Drum roll please... LIA 2015 is proud to have raised \$70,073.00 (minus expenses put us at about \$60K). Krista asked Amy & Elise for a list of all volunteers. Some discussion took place about reserving Kirk Hall for March 5, 2016 because Gary (the auctioneer) is available that date but is booked the following weekend. [Action item]: Cari will look into when the CRMS/CVHS Shamrock Shindig will take place next year because it is believed that they will have rights to Kirk Hall on March 5 based on their 2015 Kirk Hall reservation.

## 3. Event Update: Teacher Appreciation (Kerry Trietley)

First meeting took place this morning. There was a good turnout. The committee has decided on a super hero theme. The tradition of Tuesdays in May will continue. The committee would like to tie the super hero theme into either the Circle of Courage or, the Character traits. The committee would like to do a teacher board and ask the teachers to share "super hero moments". Each teacher will get a tshirt that reads, "Teaching is my super power!" Teachers and students would be encouraged to wear super hero t-shirts to school. The first week in May will include decorating doors and Noodles for lunch. The second week will include breakfast and smoothies with a "power pack" that has an energy bar, etc. inside. The committee would like to have the massage therapist in the teacher lounge again. Deborah recommended massage after school rather than lunch time. The third week will include Lost Coffee again with a healthy snack bar during lunch through the afternoon. The fourth and final week will include end of year gifts in addition to student thank you notes and a coffee bar in the lounge. Throughout the month the committee would like to do something in the hallway way, the lounge, an announcement on marquee, and posters on doors. The committee would also like to purchase a flag for in front of the school. After some discussion around the idea, Cari motioned to purchase a Teacher Appreciation flag at a cost not to exceed \$200. Deborah seconded motion. All in favor. None opposed. In addition, there will be a cash jar at the front desk for change for coffee. There was also some discussion about having a table at pickup and/or drop off to collect change for coffee as well. Kerry will get information to Andrea for the electronic newsletter. Deborah reminded Kerry to include all staff. Kerry asked about parents using PayPal accounts to collect monetary donations for end of year teacher gifts. Everyone felt like it would be an individual crew parent decision. [Action item]: Krista will get some t-shirt contacts to Kerry. Deborah shared that teachers love teacher appreciation and that it makes a difference.

[Action item]: Amy will loop back to Diane for any feedback she'd like to share. Krista asked Amy to share with Diane that it was a nice event and we appreciate her work.
- b. **End of School Year activity/party** Suzi Rush would like to know if we would like to have Kona Ice again. The Kona Ice truck has changed hands. Krista remembers that we would pay \$450 in the past. Krista suggested that we might look at spending \$900 without the "crew" parent discount. Krista asked what the teachers might like. *[Action item]*: Deborah will ask staff and students if they have ideas about what and when. *[Action item]*: Krista will let Suzi know that we will follow up with her.

## 10. Teacher Appreciation: Additional Funds Requested

An email thread which began on April 9 from Krista Zizzo stated, "Kristen DeBeer and Kerry Trietley have firmed up their budget for Teacher Appreciation Month and have requested additional funds. The expenses that this covers include:

- 50 t-shirts and lunch totes = \$600
- "feather flag" for front of school = \$125
- tips for massage therapist to come to school (for free) = \$50
- \$25 cushion/overage"

On April 9, Krista wrote, "I move that we approve up to \$800 for Teacher Appreciation Month expenses." Amy Stuart seconded the motion. Deborah, Cari and Brian are all in favor. The motion passes unanimously. All in favor. None opposed.

### 11. REA Board Nominations and Elections
